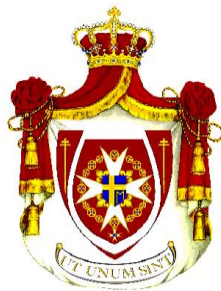

pursuant to art. 13 of EU Regulation 2016/679 and in relation to the information that will come into possession, for the purpose of protecting people and other subjects regarding the processing of personal data, we inform you as follows:

## **1. Purpose of the Treatment**

The Grand Priory of Italy Sovereign Hospitaller Order of Saint John of Jerusalem Knights of Malta o.n.l.u.s. has a legitimate interest in sharing the personal data of employees, collaborators, volunteers and members of the Order with other entities of the Order itself [Grand Pories, pories, commanderies of National Associations, diplomatic missions, foundations], including them in centralized databases: i personal data may be accessible by organizations belonging to the Order and by subjects authorized by them to process data, in compliance with reciprocal data processing agreements. The Grand Priory of Italy Sovereign Hospitaller Order of Saint John of Jerusalem Knights of Malta o.n.l.u.s. it could also transfer personal data to suppliers and third parties who perform certain services on its behalf, always in compliance with data processing agreements and, where appropriate, based on the user's consent. The data will be shared and made accessible to these external service providers only to the extent necessary to fulfill the purposes set out in this policy.

## **1. Processing Methods**

the collection, recording, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation, and distribution of data; operations can be carried out with or without the support of electronic or automated tools; the processing is carried out by owner and/or persons in charge of processing in compliance with the provisions of the law and the stated purposes.

## **2. Provision of the data**

#### 4. The Data Controller

The data controller of personal data is the Grand Priory of Italy Sovereign Order of St. John of Jerusalem Knights of Malta O.N.L.U.S.

#### 5. Rights of the interested party

At any time, you may exercise, pursuant to articles 15 to 22 of EU Regulation no. 2016/679, the right to:

- a) request confirmation of the existence or otherwise of your personal data.
- b) obtain information about the purposes of the processing, the categories of personal data, the recipients, or categories of recipients to whom the personal data have been or will be communicated and, when possible, the retention period.
- c) obtain the rectification and cancellation of data.
- d) obtain the limitation of the treatment.
- e) obtain data portability, or receive them from a data controller, in a structured format, commonly used and readable by an automatic device, and transmit them to another data controller without impediments.
- f) oppose the treatment at any time and in the case of treatment for direct marketing purposes.
- g) oppose an automated decision-making process relating to natural persons, including profiling.
- h) ask the data controller to access personal data and correct or cancel them or limit their processing or to oppose their processing, in addition to the right to data portability.
- i) withdraw the consent at any time without prejudice to the lawfulness of the treatment based on the consent given before the revocation.
